**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HENDRY COUNTY, FLORIDA, ACCEPTING THE DEDICATION OF FORD ROAD, A PORTION PREVIOUSLY KNOWN AS CITY DITCH ROAD, AS A COUNTY ROAD UNDER THE PROVISIONS OF SECTION 95.361, F.S.**

WHEREAS, the Board of County Commissioners of Hendry County, Florida has records indicating that Ford Road, a portion of which was formerly known as City Ditch Road, has been regularly maintained or repaired by Hendry County continuously for a period of more than four years from the date set forth herein; and

WHEREAS, Section 95.361, F.S., authorizes the County to accept as a presumed dedication all right, title, easement and appurtenances in and to the extent that the road has been constructed, repaired and maintained for a continuous period of not less than four years.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HENDRY COUNTY, FLORIDA that:**

1. The Board finds from the evidence presented that the roadway shown on the attached map as Ford Road, a portion of which was formerly known as City Ditch Road, has been constructed, maintained and repaired continuously and uninterrupted for a period of more than four years immediately preceding this date by Hendry County for use as a county road and thoroughfare.
2. Pursuant to Section 95.361, F.S., the Board of County Commissioners does hereby accept dedication of that certain portion of Ford Road as shown on the attached map as a county road for the use of the general public forever. Said dedication hereby vests all right, title, easement, and appurtenances in and to said portion of Ford Road in Hendry County.


3. The Board of County Commissioners hereby certifies that the road has vested in Hendry County in accordance with Section 95.361 (1), Florida Statutes.

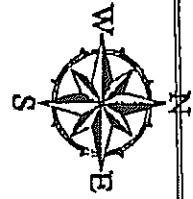

**Legend**

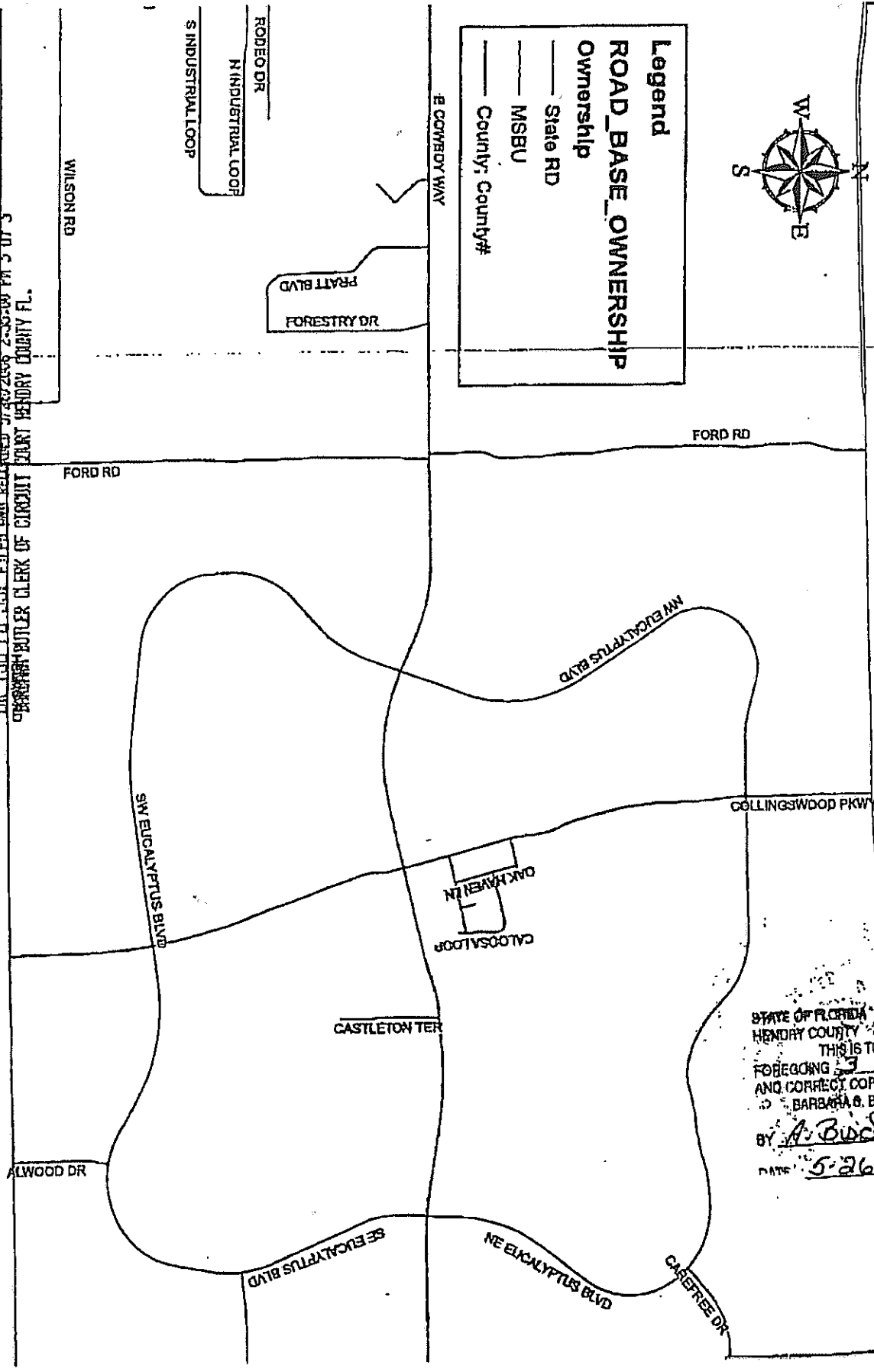
**ROAD\_BASE\_OWNERSHIP**
